

ABOUT US

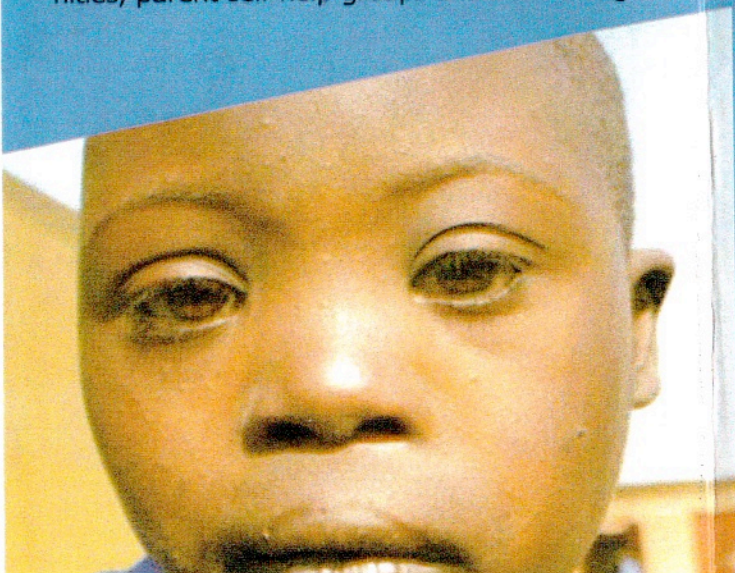
Inclusion (Uganda Association for the Mentally Handicapped) is a non-governmental organisation that works with Persons with Intellectual Disabilities.

Inclusion Uganda was established in 1983 by a group of parents and professionals of children with intellectual disabilities who came together to find a common solution to the problems that were affecting their children both at home and in the communities. The organisation started with parents in Kampala but later spread out to various parts of the country. In 2003 the organisation changed its name to Inclusion Uganda.

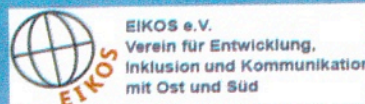
